There is a budget of \$18k and Rui is estimating that he will come under budget by \$5-6k for the Ball according to his handout (see attachment) we will be at the Museum of Commerce not at DeLuna Winery. Rui also is requesting help with set up and take down at the Museum of Commerce day of Ball.

Rui also suggested in lieu of a Krewe Golf tournament that we consider a Skeet Shoot. More on that to follow, still trying find a Golf location that will host us. Annual Halloween Party possibly held at the Museum of Commerce. More to follow. Randy is working the Golf tournament to land a location, but it's not been an easy road due to our reputation of past transgressions at those tournaments. He has mentioned that we need to clean up the image of the Krewe for future endeavors.

Treasurer's Report for your review and the latest budget spreadsheet. Please note that we are tracking to be at an overall Net Profit of \$56 after Roll Call. We originally budgeted for a Net Profit of \$902.85 at year end. We have a little ground to make up but the main thing is coming in without a Net Loss. If we don't have a Golf Tournament we will need another source of revenue that will earn us a net profit of at least \$5,000. The good news is that we still have \$3,156 from the Movember Event should we need it.
