The regular meeting of the Board of Directors scheduled for Tuesday, May 10 2022, at 6:00p.m., held at Krewe of Andres de Pez World Headquarters. The President called the meeting together at 6:05pm.

Last month's Board meeting minutes were approved, motioned by Justin Spence and 2nd by Erik Goss. April's minutes have been added to the newest Crow's Nest page in Facebook.

The President opened the floor to stating that our loan has been signed off and that the money has been added to our bank account for the construction improvements in the Barn. Bell Steel will be making the beams we will use for the project. On that subject we are in need of a Project Manager and drawings for the construction that is to start in June after the Fiesta Parade, any ideas for the drawings and Project manager will be listened to. More to follow.

Randy P. and his Golf committee nailed the tournament held at Cypress Lake GC. It was a success and Randy has been asked by many to hold next year's Krewe golf outing there again.

We need to keep not lower membership so that we make our budget, if we keep the numbers where we are around 285 members there will be no more out of pocket expenses. It was brought up about moving New Member dues by 10 July and current member dues back MM/DD??

It was also mentioned that the sooner we can bring in the New Members, the easier it would be to vet them. Clay is still hard at work to get us an SOP on the New Member Orientation. More to follow.

Siguenza has made it known that he intends to take both Floats to Fiesta Parade on the 3rd of June. He has also made it

clear what our dress code shall be and that is Tabard, with a white shirt and shorts dark in color and closed toe shoes. Dress accordingly by his requests, but keep in mind it's HOT!
